Ngarlawangga person as defined in the Ngarlawangga Peoples Determination (WCD2016/0070)

Ngarlawangga People	The Ngarlawangga People are those persons who: (a) are descended from, in accordance with the traditional laws acknowledged and the traditional customs observed by the Ngarlawangga People: i. Kanpanta; ii. Jilwilingpa; iii. Partatalpu (Maggie); iv. Kuntiri (Topsy Coony); v. Mulunu (Piper); vi. Laripangu; vii. Jimmy Tumbler viii. Mirruru (Kitty); ix. Kujamurra (Standard); and x. Kurnipa/Annie or are adopted by such biological descendants in accordance with the traditional customs observed by the Ngarlawangga People; (b) identify themselves as Ngarlawangga under traditional law and custom and are accepted in accordance with the traditional laws acknowledged and the traditional customs observed by other Ngarlawangga People as Ngarlawangga; and (c) have a connection with the land and waters of the Determination area, in accordance with the traditional laws acknowledged and the traditional customs observed by the Ngarlawangga People.

- A. The Applicants are bound by the Ngarlawangga People Northern Claim Area Participation Agreement.
- B. Each Signatory is a member of the Ngarlawangga People.
- C. By this document each Signatory promises to comply with the terms of the Ngarlawangga People Northern Claim Area Participation Agreement.

Each Signatory undertakes and agrees as follows:

1. DEFINITIONS AND INTERPRETATION

1.1 Definitions

The following definitions apply in this document.

Ngarlawangga People Northern Claim Area Participation Agreement means the agreement entitled "RTIO and Ngarlawangga People Northern Claim Area Participation Agreement" between:

- (a) Hamersley Iron Pty Limited ACN 004 558 276;
- (b) Robe River Mining Co Pty Ltd ACN 008 694 246 on its own behalf as a Venturer and as Manager for and on behalf of the Robe River Iron Associates;
- (c) Hamersley HMS Pty Ltd ACN 115 004 129 as Manager for and on behalf of the Hope Downs Joint Venturers;
- (d) Hamersley Resources Ltd ACN 004 887 656 on its own behalf as a Venturer and as Manager for and on behalf of the Rhodes Ridge Joint Venturers; and
- (e) Tadgee Limmerick, Maisey Hyland and Dianne Limmerick individually while members of the Ngarlawangga People and for and on behalf of those members of the Ngarlawangga People who have the capacity to contract as at the commencement date of the agreement,

as amended from time to time.

Signatory means each natural person that has executed this deed poll.

1.2 Terms defined in the Ngarlawangga People Northern Claim Area Participation Agreement

A term (other than a term defined in clause 1.1 of this document) that is defined in the Ngarlawangga People Northern Claim Area Participation Agreement has the same meaning as in the Ngarlawangga People Northern Claim Area Participation Agreement.

1.3 Rules for interpreting this document

The rules for interpreting the Ngarlawangga People Northern Claim Area Participation Agreement set out in clause 1.2 of the Ngarlawangga People Northern Claim Area Participation Agreement apply to this document, except where the context makes it clear that a rule is not intended to apply.

1.4 Inconsistency with the Ngarlawangga People Northern Claim Area Participation Agreement

If this document is inconsistent with the Ngarlawangga People Northern Claim Area Participation Agreement, the Ngarlawangga People Northern Claim Area Participation Agreement prevails to the extent of the inconsistency.

2. COVENANTS GIVEN BY EACH SIGNATORY

Each Signatory promises to RTIO that (without limiting the operation of the Ngarlawangga People Northern Claim Area Participation Agreement) they:

- (a) are a member of the Ngarlawangga People;
- (b) authorised the Applicants to enter into the Ngarlawangga People Northern Claim Area Participation Agreement on their behalf; and
- (c) are bound by and will observe, perform and comply with the provisions of the Ngarlawangga People Northern Claim Area Participation Agreement as a member of the Ngarlawangga People.

3. VOLUNTARY EXECUTION

Each Signatory acknowledges and agrees that:

- (a) they are aware of:
 - (i) the contents of the Ngarlawangga People Northern Claim Area Participation Agreement; and
 - (ii) how this deed poll interacts with the Ngarlawangga People Northern Claim Area Participation Agreement;
- (b) they have voluntarily executed this deed poll;
- (c) before the execution of this deed poll, they have obtained legal advice; and
- (d) as a result of that legal advice, they understand the nature and effect of this deed poll and the Ngarlawangga People Northern Claim Area Participation Agreement.

4. GOVERNING LAW

- (a) This document is governed by the law in force in Western Australia.
- (b) Each Signatory submits to the non exclusive jurisdiction of the courts of Western Australia, and any court that may hear appeals from any of those courts, for any proceedings in connection with this deed poll.
